### Chairman's Report – David Maxwell December 5, 2012

Hello fellow forage producers:

Once again, this year brought plenty of challenges to the agriculture industry. Many of us started the year with more water than we really needed. My timothy and alfalfa crops handled the water better than my annual crops. This is why we need to hedge the weather bet and plant forages. Later in the summer, however, my timothy crop was attacked by true armyworm. This is why we need more research and crop protection products in forage seed production.

Your Board has been working well this year through conference calls, in-person meetings and our summer field day. I want to thank the members of your Board for their dedication to the industry. We added two new Directors this year, Nels Smelland and James Silcox of Nipawin, SK. I have been the Chairman of the Commission for three years and it is certainly a great help to have the full complement of Board members this year. In 2014, we will see four of our Directors' terms expire. I want to encourage any levy payer who is interested in advancing our industry through the efforts of the Commission to contact me, or any of the Directors, to discuss the activities of the Board and to consider letting your name stand as Director.

Nancy Johns left the Commission in March to expand her crop advisor business. Thank you to Nancy for her efforts over the past five years! In the same month, we hired Ray McVicar as the new Executive Director. Ray has been doing a great job of organizing this bunch of farmers. Thank you Ray!

The Saskatchewan Agri-Food Council has been very helpful in keeping us on the straight and narrow regarding Provincial policies affecting Commissions.

The Commission continues to promote the forage seed industry with a limited budget. We have asked the Saskatchewan Ministry of Agriculture to champion increased funding for forage seed research in the upcoming Growing Forward II program, and we are working with the newly formed Saskatchewan Forage Network to raise awareness of the need for increased forage seed research capabilities in our Province.

Our annual field day was held at Carrot River in July. Despite heavy rainfall the previous day, we managed to look at some research projects in the field and had a tour of the AG-Vision Seeds facilities. Thank you to AG-Vision Seeds and others for their hospitality and efforts.

I am pleased with the research projects that have been carried out this year. We continue to look for good research projects that will advance our industry. We spend your money on projects that will benefit your farm, so please contact any of the Directors to provide us with guidance for the future.

At the Commission, we are very positive about the industry as forages will always be a significant cog in the wheel of agriculture. Please keep forages in mind for spring planting next year. High input crops are okay, but forages have a great fit for spreading the workload, nitrogen production, improving the tilth of the soil and making money.

### Saskatchewan Forage Seed Development Commission (SFSDC) Executive Director Report for 2011-2012

Ray McVicar - December 5, 2012

The 2011-2012 year began with Nancy Johns working as Executive Director of the Commission. In March 2012, Nancy left to increase her crop advisor business. Nancy played a very important part of the Commission's past five years and her efforts are greatly appreciated.

I began with the Commission in April 2012, after retiring from Saskatchewan Agriculture after about 19 years in the Crops Branch. I want to thank the Board of Directors and the levy payers of the Commission for the opportunity to act as Executive Director.

The 2011-2012 fiscal year was the first year in many that saw an increase in the number of levy payers and an increase in the levy contributed to the SFSDC. The higher prices paid for other crops such as canola and wheat have placed pressure on forage seed crops to keep up in the competition for growers' acres. Forage seed prices did improve this year and it is hoped that this indicates the industry is on the move upward.

Thank you to all of our levy payers and the forage seed crop buyers who contributed their funds, time and efforts to the Commission.

The Commission's research focus continued with a number of forage seed research projects completed or continued in 2011-2012 and two new projects were initiated. ADOPT projects with funding from Saskatchewan Ministry of Agriculture were: Fertilizing Forage Grasses for Seed Production (continued), Pod Sealant Technology in Trefoil Seed Production (completed), Bromegrass Seed Midge Control (completed) and Fungicides for Use in Forage Seed Grasses (initiated). Thank you to Saskatchewan Agriculture for their support.

The SFSDC continued the research into Bromegrass Seed Midge Control by funding its own project on hybrid bromegrass in the Carrot River area during the 2012 growing season. The report will be available shortly.

The SFSDC provided \$4,000 towards the initiation of a new fertility project "Improving Nitrogen Use Efficiency in Forage Seed Production" led by Dr. Fran Walley at the University of Saskatchewan. An initial report is included in the Fall 2012 SFSDC Newsletter.

We continue to partner with the University of Alberta by providing \$1,000 per year for three years to their research on "Pheromone-Mediated Mating Disruption" for red clover casebearer. The project is currently in year two, and their interim report is included in the Fall 2012 SFSDC Newsletter.

The Invasive Plant Species project with Saskatchewan Forage Council and the Frenchman-Wood River Weed Management Area continued with an assessment of the Weed Free Hay project and the production and distribution of Invasive Plant Species Best Management Practice publications. A booklet was also distributed on indentifying invasive plant species.

Significant efforts were made by Nancy Johns and consultants toward the development of the SFSDC Website. We continue to make improvements and updates at the site, so please check it out at: www.skforageseeddc.com

The SFSDC Board of Directors held five board meetings or conference calls during the 2011-2012 year as well as the grower information session held in Nipawin, SK on December 6, 2011. Unfortunately, the very wet weather washed out the annual field day planned for July 2011.

Prairie Seeds Newsletter is an extremely important method for the Commission to communicate with our levy payers, buyers and researchers. Two editions were planned and published during the 2011-2012 year. If you receive more than one copy or have some suggestions for articles you would like to see in future newsletters, please notify the SFSDC office. The Commission also provided copies of the Forage Seed News to current levy payers in order to help keep up on current issues in the forage seed industry throughout the Prairies.

# Merv Culham, Chartered Accountant

To the Members of Saskatchewan Forage Seed Development Commission

I have audited Saskatchewan Forage Seed Development Commission's control as of June 30, 2012 to express an opinion as to the effectiveness of its control related to the following objectives.

- To safeguard agency resources. That is, to ensure its assets are not lost or used inappropriately; to ensure it does not inappropriately incur obligations; to establish a financial plan to achieve its goals; and to monitor and react to its progress towards the objectives established in its financial plan.
- To prepare reliable financial statements.
- To conduct its activities following laws, regulations and policies related to financial reporting, safeguarding agency resources, revenue-raising, spending, borrowing and investing.

I used the control framework developed by the Canadian Institute of Chartered Accountants (CICA) to make my judgements about the effectiveness of Saskatchewan Forage Seed Development Commission's control. I did not audit certain aspects of control concerning the effectiveness, economy, and efficiency of certain management decision-making processes.

The CICA defines control as comprising those elements of an organization's objectives that, taken together, support people in the achievement of the organization's objectives. Control is effective to the extent that it provides reasonable assurance that the organization will achieve its objectives.

Saskatchewan Forage Seed Development Commission's management is responsible for effective control related to the objectives described above. My responsibility is to express an opinion on the effectiveness of control based on my audit.

I conducted my audit in accordance with standards for assurance engagements established by the Canadian Institute of Chartered Accountants. Those standards require that I plan and perform an audit to obtain reasonable assurance as to effectiveness of Saskatchewan Forage Seed Development Commission's control related to the objectives above. An audit includes obtaining an understanding of the significant risks related to these objectives, the key control elements and control activities to manage these risks and examining, on a test basis, evidence relating to control.

Control can provide only reasonable and not absolute assurance of achieving objectives reliably for the following reasons. There are inherent limitations in control including judgement in decision-making, human error, collusion to circumvent control activities and management overriding control. Cost/benefit decisions are made when designing control in organizations. Because control can be expected to provide only reasonable assurance and not absolute assurance, the objectives referred to above may not be achieved reliably. Also, projections of any evaluation of control to future periods are subject to the risk that control

may become ineffective because of changes in internal and external conditions, or the degree of compliance with control activities may deteriorate.

In my opinion, based on the limitations noted above, Saskatchewan Forage Seed Development Commission's control was effective, in all material respects, to meet the objectives stated above as of June 30, 2012 based on the CICA criteria of control framework.

#### INDEPENDENT AUDITOR'S REPORT

To The Board of Directors of Saskatchewan Forage Seed Development Commission

I have audited the accompanying financial statements of the Saskatchewan Forage Seed Development Commission which comprise the statement of financial position as at June 30, 2012, and the accompanying statements of operations, change in net financial assets and cash flow for the year then ended, and a summary of significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statements

#### 1. Nature of entity

Saskatchewan Forage Seed Development Commission operates to promote and enhance the forage seed industry in Saskatchewan for maximum return to producers through research, leadership and communication in the industry.

Saskatchewan Forage Seed Development Commisson is a non-profit organization incorporated under the Agri-Foods Act, 2004 of Saskatchewan. Under present legislation, no income taxes are paid on the reported income of such operations.

#### 2. Accounting policies

The carrying amount of cash and term deposits - approximates their fair market value due to the short term maturities of these items.

The company does not have a significant credit exposure to any individual customer or counterpart.

Levy funds are recorded as revenue when received or receivable, if the amount to be received can be reasonably estimated. Other revenues are recorded as earned.

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenditures during the reporting period. By their nature, these estimates are subject to measurement uncertainty and the effect on the financial statements of changes in such estimates in future periods could be significant.

The budgeted figures are presented for comparison purposes as prepared and approved by the Board, reclassified to conform to the current financial statement presentation. They have not been audited or reviewed.
