



## BUYER REGISTRATION

Declaration: As a purchaser of Saskatchewan grown forage seed, “a regulated product under the *Agri-Food Act* of Saskatchewan,” we hereby file for registration as required under the *Act*. We state that we will comply with the *Agri-Food Act*, the *Saskatchewan Forage Seed Development Plan Regulations* available at: [SFSDC Regulations](#) and the related Board Orders available at: [SFSDC Board Orders SK](#) and [SFSDC Board Orders - Canada](#)

All sales of forage seed are subject to a levy of 0.75% of the gross value of forage seed marketed upon final settlement made to producers.

“forage seed” means all forage grasses; forage legumes other than alfalfa seed; species used for turf, amenity and reclamation or regeneration purposes, including commercial varieties of native forage grasses and legumes; and includes all grades of forage seed and all potential mixtures.

### Levy Collection Information

The levy collection for the Saskatchewan Forage Seed Development Commission, Period One, is from July 1 to December 31 and Period Two is from January 1 to June 30.

For last year’s crop, the levy collection period is July 1, 2022 to December 31, 2022 and Period Two is from January 1, 2023 to June 30, 2023.

All levy monies must be submitted to the Commission office within 55 days from the end of the semi-annual period within which the levy was collected. Semi-annual periods are January 1<sup>st</sup> to June 30<sup>th</sup>, and July 1<sup>st</sup> to December 31<sup>st</sup>. Levy remittance may be done by cheque or by auto-deposit (EFT).

Each buyer shall deduct the levy from any proceeds payable to a producer when forage seed is:

- (a) purchased from a producer; or
- (b) acquired from a producer for sale on the producer’s behalf.

Each levy submission to the Commission office must include the following information with respect to each producer for whom a levy is submitted:

- (a) the name, address, phone number and email address (if available) of the producer;
- (b) the crop kind, type, and lot number (if available) purchased from the producer;
- (c) the gross value of forage seed purchased from the producer; and
- (c) the amount of levy being paid on behalf of the producer (including initial and final payment, if applicable).
